### **1.4. Metodología del Seminario:**

In the second and third sessions we will have substantive discussions about the role that international law and international institutions can play in relation to Russia's aggression against Ukraine. Students will be expected to prepare themselves for these sessions reading the assigned materials. This will be explained in the introductory class.

After these two sessions, students will have to submit a proposal containing the topic for their article, an overview of their main argument, and a preliminary bibliography.

In the following three sessions we will discuss research methodology. This is, the strategies and techniques that are necessary to write an academic paper.

The last group session will be held the week before the preliminary reports are due. The objective is to discuss the drafts that students will be expected to be already working on.

The last session will be individual. The purpose is to review the preliminary report and discuss the following steps towards the completion of the article.

The Seminar's final mark will include in-class participation, a preliminary report and the final article. The guidelines for each of these items will be explained in the first session of the semester.
